- Rose DeCosta of Management of Exterior Affairs and Nate Mayo of Vineyard Wind provided an update about their two offshore wind projects with a particular focus on onshore transmission plans in Barnstable. The first stage of onshore construction begins with seasonal road work in 2021 while the second stage is estimated to begin in 2023. Over the next several years, these two projects will provide enough renewable wind power to over 800,000 households.
- Nancy Viall Shoemaker of West Barnstable Press, gave a preview to the book that she and historian Jim Gould are working on. The research has yielded fascinating stories of women of our Town... from witches, to sea captain's wives, to businesswomen and suffragists. The book will be available at local book stores later this spring.
