West Barnstable Civic Association Meeting Minutes Tuesday, June 7, 2022

I. Call to Order

Andrew Lee, President called to order the regular meeting of the West Barnstable Civic Association at 7:02 PM on Tuesday, June 7, 2022, at the West Barnstable Community Building, Route 149 in West Barnstable, MA.

III. Approval of Minutes

Approval of meeting minutes from May 3, 2022. Ed Jay motioned; Bob Stolte seconded. Unanimous vote taken to approve.

IV. Councilor's Report - Kris Clark

Kris provided an update on the procurement of a generator for the West Barnstable Community Building to use the building as a warming station during storms. The building will not be used as a shelter. Representative Stephen Xiarhos requested \$75,000 in the State Senate. The town as approved the installation of the generator so once the money is appropriated by the State, we will have one installed. There will be a balance from the appropriation and there was a discussion about installing a water filtration system and updated maintenance and fees for electrical updates. A general discussion took place regarding the extensive updating the town has made to our community building replacing windows, walls, and work in the basement. We were reminded that the building will need to be staffed in the event of an emergency and there will be more discussion about this, and we will prepare a list of potential volunteers for future reference.

Kris provided an updated on the work taking place on Rt 149. The improvements have stopped since Memorial Day and work on the East side of Rt. 149 will commence after Labor Day. Paving will be done in Spring of 2023. There will be no sidewalks and there is no additional money to spend. George asked to request additional monies for sidewalks and noted the overpass bridge is the only tribute to our First Responders.

Kris provided an update on the drilling of new well(s) off Hinckley Lane in WB and the potential impact to the community and our water. A discussion arose about contacting an attorney and an engineer to mitigate the potential impact to the community. It was brought to our attention that the town is facing challenges – protected species and other things were noted. The commission will be meeting the first Monday of every other month. The next meeting is scheduled for August 1st.
