Call to Order

Andrew Lee, President called to order the regular meeting of the West Barnstable Civic Association at 7:07 PM.

Attendance

Board members Andy Lee, Ed Jay, Jon Britton, Maria DeMayo, Dave Kern, Nancy Meagher, Bob Stolte, and Councilor Kris Clark were in attendance.

Approval of Minutes

Approval of corrected December 6, 2022, meeting minutes Ed Jay motioned; Maria DeMayo seconded. Unanimous vote taken to approve.

Report from Precinct 11 Councilor Kris Clark

Town and local updates:

On November 30th, I joined Judge Joe Reardon and others on his advisory committee to hear his updates and to learn of the plans to move a donated boxcar onto a more prominent area on the Lombard Trust property. There are some ownership issues that I am nudging the Town's legal department to address. Today I received a message from Asset Management Director David Anthony who is in discussions with the Town's Legal Department regarding resolving the ownership issue that is holding up action by the Cape Cod Chapter of the NHRS. This has yet to be resolved.

Judge Reardon would like a member of the WBCA board to join his committee. I had served in that capacity but now serve as the sitting town councilor. Ed Jay volunteered to serve on this committee and Maria DeMayo will be an alternate.

In light of the Town's interest to drill for municipal water in West Barnstable, the WB Water Commissioners met on December 13, 2022 at 5:00pm at the West Barnstable Community Building. The main purpose is to request that an article be placed on the Annual Fire District Warrant for future professional services for water. The Prudential Committee will have its monthly meeting the day afterwards. When the WB Water Commissioners requested the same last year, we were told that it was too late- that the document was close to being printed. The next scheduled WB Water Commissioners meeting is on February 6th (first Monday) at 6:30pm. The next Prudential Committee meeting is the day afterwards, December 14, 2022, at 4 PM.

I attended the monthly meeting of the Hyannis Water Board last month. There I suggested that the Water Board support that the Town purchase the 18 acres of open space that is now for sale by the Burke family. These 18 acres are contiguous to the Bridge Creek Conservation Area and presents a rare opportunity for the Town to purchase land for municipal water use. An easement for the Town of Barnstable was explored and not found feasible at the Burke Farm property currently for sale, due to wetland concerns. But it was agreed that the 18 acres would be a good addition to the Bridge Conservation Area for the town to buy it for additional buffer land for future water supply. The Supervisor of the Hyannis Water Supply Division plans to draft a letter for the Hyannis Water Board to approve to send to the Community Preservation Committee to pay for an appraisal for the land on that property that is not developed. The Supervisor of the Hyannis Water Supply plans to send a letter to the Town's Land Acquisition and Preservation Committee to recommend that the 18 acres be preserved for municipal water protection. The next meeting of the Hyannis Water Board will be on January 17th at 5 PM via Zoom.

I continue to express concerns over the proposal for Form Based Zoning in Hyannis.

The 28th session of the Inside Town Government class will begin on Tuesday, January 24, 2023. It will be held from 6:30 – 9:00 PM at various locations throughout the Town. The program is free of charge and open to anyone who works or lives in Barnstable. Classes are limited and are almost full. Fill out an application HERE.
